"I've witnessed the benefits of ASP's performance-based approach to development. It is truly transformational for youth enrolled in the programs and for the professionals who volunteer their time. As president of PSEG Services Corporation, Di Rasio has championed volunteerism and community involvement across PSEG. During this time PSEG's support – both financial and program participation – has burgeoned into one of the most significant corporate relationships ASP has in the nation.
