About the All Stars

The All Stars Project is a leading national nonprofit organization where young people learn new performances on and off stage. Our dynamic programs transform the lives of youth from poor and underserved communities in partnership with caring adults, giving everyone the opportunity to grow. Located in six cities — **Jersey City, New York City, Newark, Chicago, Dallas, the San Francisco Bay Area**, and now virtually everywhere—these programs are all free of charge for our young people!



Our Programs

Development School for Youth (DSY)



With a 25-year track record and over 5,000 alumni, the DSY **creates leadership training and paid summer internship opportunities for youth** in partnership with the business community. This summer, 200 youth participated in in-person, virtual, and hybrid internships provided by partner companies such as EY, JPMorgan Chase, MetLife, Paramount Global, CBRE, and Brookfield Asset Management. DSY has been featured in the [Chicago Tribune](#) and [Forbes](#) as a **model program in preparing youth for the business world** and creating meaningful engagement, as our corporate partners respond to new calls of action for diversity and equity in the workplace.

Development Coaching

A **brand-new** program of the All Stars developed in response to COVID-19, Development Coaching **matches young people with caring adults** and industry leaders. These adults help guide and enhance each young person’s professional and personal development. Since 2020, we’ve matched over 1,000 young people and adults in the program!

Performance Programs

Through on-stage and online performance activities – including our [All Stars Talent Show Network](#), [Youth Onstage!](#), and [Virtual Performance Playbook](#) – the All Stars uses our innovative performance-based approach to help young people from across the country (and the world!) grow their confidence on stage and in life!

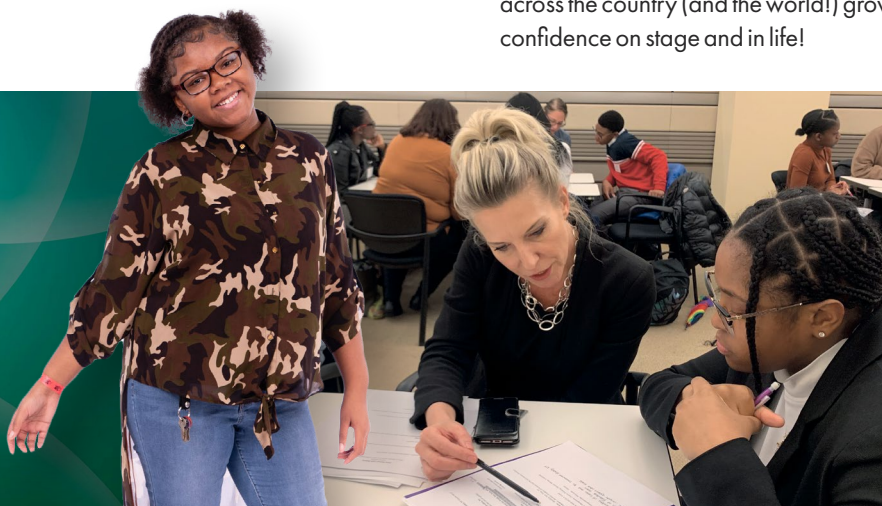


Operation Conversation: Cops & Kids

Cops & Kids is an **award-winning, police-community relations model program** run in partnership with the New York City Police Department and the Newark Police Department. We have worked directly with over 5,000 youth and officers over the past decade, who have built new relationships with one another through their engagement with the program.

Dr. Ralph Izzo

Executive Chairman, PSEG

Dr. Ralph Izzo is the executive chairman of PSEG, a publicly traded, diversified energy company based in New Jersey. Before becoming CEO in 2007, Dr. Izzo served as PSEG’s president and chief operating officer. Ralph was the recipient of the 2022 US Energy Award for his contributions to the energy industry over three decades, a career which began as a research scientist at the Princeton Plasma Physics Laboratory.

Through performance, All Stars teaches disadvantaged youth that they have a lot to offer, be it through an All Stars talent show performance or paid internships. But it does not stop there. It also reaches out to donors, mentors, and adult volunteers and makes it clear that we can learn a lot from these interactions as well. It creates venues and spaces where people from diverse backgrounds and economic means can share experiences, have true conversations, and write new stories of our lives, together.

Our Impact

All Stars Project Outcome Evaluation Results

Over our 41-year history serving the community, the All Stars and our supporters have seen the real impact our work have on the lives of underserved young people living in poverty through our performance-based development programs. And to help identify and quantify that impact, the All Stars recently completed a 5-year evaluation study together with **Southern Methodist University (SMU)** and their **Center on Research and Evaluation** that shows there is a significant increase in eight key dimensions of development that empower youth to be successful in both education and workplace situations, and to fully participate in every aspect of society. We are proud to share this study – **which included over 700 young people in 6 cities and 100,000 data points** – scientifically demonstrates and validates the tangible impact of All Stars youth programs!
