## All Stars Project Programs for Youth!

By supporting the All Stars Project Fall Benefit & Golf Classic, you are contributing to All Stars' mission to transform the lives of youth from poor and underserved communities in partnership with caring adults, giving everyone the opportunity to grow.

**Our volunteer-led programs** include the [Development School for Youth](#), where corporate partners lead workshops in networking, interviewing, resume writing and workplace etiquette both in-person and virtually. Successful graduates of the program become eligible for paid summer internships. Our [Development Coaching](#) program **pairs coaches and coachees based on interests and experience** to build a positive relationship, grow the young person's network, and navigate life challenges over 8-weeks of open conversations held virtually.

All Stars' programs are proven to help underserved young people grow in three categories, including **Relating to Others, Navigating Professional Settings, and Engaging with the World**. Findings from the 5-year study conducted with Southern Methodist University can be found [HERE](#).

**All Stars is proud to partner with outstanding corporate and community organizations** as we scale our impact and leadership in the field of afterschool.
