As I reflect on my first year as CEO, I am deeply grateful for your unwavering commitment to our mission. The All Stars Project's work has never been more vital, and I am inspired by the enthusiasm with which our young people across the country are embracing opportunities to grow.

In 2023, we recommitted ourselves to our grassroots focus, reestablishing in-person programming in underserved communities nationwide.

Our volunteers and staff touched the lives of over 8,400 young people, providing the transformative experiences that are the hallmark of our work. As a nation, we face profound challenges in uplifting our marginalized youth; All Stars remains at the forefront of innovation in this critical arena.

I was honored to meet the U.S. Surgeon General earlier this year at the Aspen Ideas Festival, where he underscored the mental health crisis gripping America's youth. He called for the creation of environments fostering "belonging, purpose and service"—the very principles that have guided the All Stars Project's work for the last several decades. As we move forward, we will redouble our efforts to create these healing, empowering spaces for young people across the country and share what we have learned with others through training and collaborations.

A centerpiece of my work as CEO is to develop and support the next generation of talent and leadership at All Stars. The appointment of Antoine Joyce and Shadae McDaniel to Senior Vice President roles is a testament to the dynamic bridge builders within our ranks. I am thrilled to collaborate with them, our new executive leadership team and our Board Chair, Nathaniel Christian, III, to shape the future of All Stars.



All Stars is committed to moving beyond silos toward constructive collaboration and partnership. We are proud to count among our newest and growing partners the ICA Cristo Rey Academy, Dallas College, the Newark Police Division, Paramount Global and KPMG. Also embracing our approach—and the playbook we have written on how to create impactful development and internship experiences—is Big Thought in Dallas,

whose President and CEO, Byron Sanders, invited Gabrielle Kurlander and me to author a chapter for a new book, *Built for More: The Role of Outside-of-School Time in Preparing Youth for the Future of Work*.

Everything we do is made possible by the generosity of our supporters. In 2023, close to 2,000 people, companies and foundations invested a total of \$11.3 million, resulting in one of the most successful philanthropic years

in our history. This investment will allow the community we are building—young people, adult volunteers, alumni and nonprofit partners—to continue to deepen our impact everywhere.

As I look to the future, I am filled with optimism. The potential of our "community of development" is limitless, and with your steadfast support, I know that All Stars will be a beacon of hope and transformation for years to come. Thank you for being on this journey.

# Partnership with Caring Adults

All Stars partners with caring adults who help guide and enhance the personal and professional development of young people in programs such as the **Development School for Youth (DSY)** and **Development Coaching**. We create community by bringing together caring adults—who serve as development coaches, DSY program associates, workshop leaders and internship supervisors—and poor and underserved youth so that they can build something new together.

# Bridge Building

**Operation Conversation** and **Operation Conversation: Cops & Kids** are All Stars' innovative bridge-building initiatives.

Operation Conversation was created to address the social and racial divides in America. In a two-part workshop, people from diverse communities and all walks of life learn and perform with new tools that develop empathy, appreciation, active listening and curiosity. All Stars Project is working with Fortune 500 companies interested in integrating Operation Conversation into their diversity and inclusion initiatives.

In 2023, All Stars was proud to continue our partnership with the Newark Police Division (NPD) through the development of a curriculum used to train its 1,000+ officers in our innovative approach to community policing. In New York City, All Stars hosted monthly ensemble-building workshops with young people referred to us by the New York City Police Department's (NYPD) Manhattan South Precinct.

Another 2023 highlight was our social justice partnership with the New York Jets, in which dozens of players and staff stepped up to volunteer throughout the year. In addition to serving as development coaches, 17 members of the Jets' rookie class, All Stars alumni and officers from the NPD signed up for the **Cops & Kids: Creating Conversations Workshop**.

# In the Community

**All Stars was all about outreach in 2023.** In cities around the country (and virtually), our teams visited classrooms and school fairs, knocked on doors and set up tables at community events, and partnered with other afterschool programs to reach 8,416 young people. As a result of these efforts, and with strong support from All Stars alumni, over 1,980 young people applied to our youth programs.

In addition to volunteering with our DSY and Development Coaching programs, people from all walks of life joined us in a variety of community-building activities and as leaders of our performance and development programs.





# Measuring Our Impact

**All Stars continued to disseminate our outcome evaluation** conducted by the Southern Methodist University's Center on Research and Evaluation. This groundbreaking report systematically validates All Stars' discovery that development—as a foundation of learning that takes place when young people venture outside of daily school and life experiences—can be measured. It also shows that young people advance their own development through participation in our programs.

The evaluation process also identified and validated eight Dimensions of Development that, when strengthened, help youth to grow. At the heart of the All Stars model, these strengths and capabilities are closely related to what many refer to as 21st century skills—a set of skills now valued in corporate, educational and daily life environments because they are based not on what we know but on how well we can learn new things, collaborate and build relationships with people from differing backgrounds, beliefs and life circumstances.

# Strategic Partnerships and Model Building

## In 2023, All Stars continued to build on its success as an action and thought leader.

Through innovative collaborations and strategic partnerships, All Stars worked closely with nonprofit, community college and corporate partners interested in incorporating our performance approach in the design and implementation of training solutions and new afterschool programming as well as in the creation of workforce development and diversity and inclusion initiatives. We further invested in thought leadership activities, conversations, writing and research to advance afterschool development as a field and a game-changing strategy for social transformation. Together with like-minded partners, we are testing the scalability of our approach and, most importantly, reaching many more youth.

## ICA Cristo Rey Academy

### Advancing a workforce model for a national high school network



All Stars Project has formed a partnership with ICA Cristo Rey Academy, a 140-year-old all-female college-preparatory high school in San Francisco. Our partnership with ICA Cristo Rey is designed to empower young people to be leaders of their lives and communities, dramatically increase impact through each organization's strengths and achieve outcomes

based on All Stars' eight dimensions of development and 21st century skills. In 2023, the collaboration included several performance workshops and experiences that empowered students from poor communities in the San Francisco Bay Area to build confidence, try new roles and create new opportunities for their future in college and the workforce.

## Dallas College

### Preparing college students for 21st century workplace success

In 2023, All Stars was honored to receive the Beacon Award, which recognizes partners with extraordinary passion and commitment to the mission of Dallas College—one of a growing number of educational institutions and employers across the country who recognize that academics alone does not guarantee success especially for young people growing up in poverty. Over the year, the All Stars team facilitated a workshop pilot for 25 Dallas College student interns and supervisors in the Employer Resource Center, led a career and technical education workshop pilot for 29 Dallas College staff focused on communication, critical thinking and teamwork and conducted a training with over 100 students and 48 corporate volunteers at five companies for a performance workshop on communication and networking.



## KPMG

### Developing a national high school internship program

As part of KPMG's Accelerate 2025 initiative—which focuses on ensuring that individuals from underrepresented groups advance to leadership positions within KPMG and the broader accounting services community—All Stars was invited to design and develop the Empower High School Experience (EHSE). A summer apprenticeship program, EHSE involved a diverse group of 200 young people—including 21 rising high school juniors and seniors enrolled in All Stars programs—in three-plus weeks of paid summer internships in 11 markets across the country.



# Paramount Global

Creating apprenticeships that promote diversity and development in the workplace



As part of Paramount Global’s commitment to ensuring that young people of color can emerge as successful candidates for employment, the company partnered with All Stars to expand a jointly designed apprenticeship training

initiative. In addition to scaling up its 2023 summer internship program commitment to DSY, Paramount Global began working with us on institutionalizing and expanding this effort. They also developed pro bono an All Stars Project Public Service

Announcement, which reached tens of millions of households nationally through its distribution on cable channels and social media platforms.

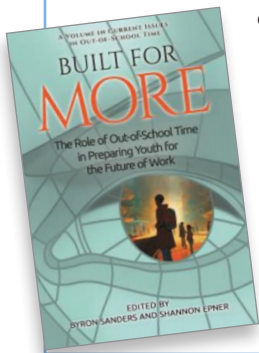
## Advancing Thought Leadership Activities

# Building Community Across the Country

## All Stars Project of Chicago

In 2023, All Stars Project of Chicago proudly opened its Hub for Afterschool Development in the historic Printer's Row neighborhood, with hundreds of philanthropic partners contributing close to \$11 million in support of this effort. The 6,264-square-foot Hub gives young people a space of belonging and opportunity where they can realize their creative potential and make use of the entire city as a campus for development. It is also a gathering place for community-based partners, which include organizations involved with the ASP of Chicago Afterschool Development Working Group.

In a year in which we enjoyed a robust return of in-person performance programming, All Stars joined with the Cook County Sheriff's Department and Chicago HOPES for Kids to produce an All Stars Talent Show Network Pop Up Performance at which a lively array of young singers, dancers and spoken-word performers were cheered on by 140 community members. Community outreach efforts reached over 2,800 young people, including 90 juniors at Catalyst Maria High School who participated in our first in-school resume prep workshop led by partners at EY and Driehaus Capital Management.

# All Stars Project of Dallas

In 2023, All Stars celebrated **A Decade of Development** in Dallas in the only way we know how—by bringing development and opportunity to young people in Oak Cliff, South Dallas and West Dallas, who are otherwise left out of the city’s current wave of growth. We hosted our first in-person talent show with community partner St. Philip’s School and Community Center in South Dallas. In the fall, All Stars launched an innovative Fall Leadership Program designed to introduce participants to different industries, including banking and real estate.

Under the leadership of Antoine Joyce, SVP/Dallas City Leader, and Natalie Sandifer, Associate Director, we deepened our strategic partnership with Dallas College and launched a collaboration with the University of North Texas (UNT) Dallas and its Trailblazers Elite Program. We also began working with UNT’s Conrad Leadership Program, which was founded by Texas State Senator Royce West to help students gain employment experience before they graduate. Antoine Joyce was a featured speaker at events hosted by Fidelity Scholars, the Kennedy Center and others. A 2023 graduate of the Presidential Leadership Scholar Program, Antoine is currently enrolled in the Leadership Arts Institute in Dallas.

# Building Community Across the Country

## All Stars Project of New Jersey

In 2023, ASP of NJ celebrated its first full year of programming at our beautiful suite of offices and performance spaces at the Gateway Center, which has increased our visibility across the city and made it possible for many more young people, organizations and communities to be part of creating a forward-looking Newark. All Stars also partnered with the NPD on the design of a new Youth Engagement Strategy training initiative for its 1,000+ officers in our innovative approach to community policing. In recognition of this work, All Stars received a Community Partnership Award from the Department of Public Safety as well as a grant from the Office of Violence Prevention and Trauma Recovery. We were also invited to join the Brick City Peace Collective, which is spearheading a citywide community-based violence intervention and prevention strategy. Additionally, All Stars was pleased to forge a partnership with the Newark Symphony Hall, which welcomed 125 youth to its historic space for All Stars' community talent show.

All Stars SVP/ASP of NJ Director Shadae McDaniel was honored by the Newark Boys Chorus with a 2023 Rainbow Gala for Leadership in Youth Development Award and was once again named by *ROI Magazine* as one of their 2023 People of Color Influencers.

# All Stars Project of New York

As All Stars in New York creates a new stage and a new chapter of impact, we are doubling down on developing meaningful partnerships that expand our reach to young people and their families, building a broader, dynamic presence in poor communities across the five boroughs. In 2023, these partnerships included Here2Here, Thompson Drive and YouthBridge-NY, all of which hosted All Stars-led youth performance workshops for the young people they serve. We also continued our decades-long collaboration with the NYPD through monthly ensemble-building workshops with young people organized by NYPD’s Manhattan South. Additionally, dozens of young people, staff, volunteers and donors came together at the African American Day Parade in Harlem, where a vibrant, multiracial contingent marched under the banner “Always Growing, Always Performing, Always Building — Always All Stars!”

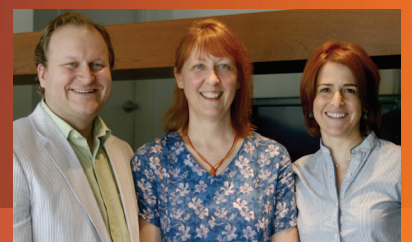

# Performance Lab

Performance Lab, All Stars' newest initiative, partners with theatre artists and organizations across the country to showcase and produce cultural events and bridge-building activities that explore human relations and social conflict through the lens of performance—both on stage and in life.

## Performance Lab Initiatives

Performance Lab is led by Gabrielle Kurlander, All Stars Founding CEO (1989–2023) and a member of the ASP Board of Directors. Ms. Kurlander also has a 35-year career in political, multicultural and avant-garde theatre as an actor, award-winning director and producer.

Performance Lab initiatives include Operation Conversation (see Bridge Building on page 4), Pro Seminar Series and Transformative Community Theatre Collaborations.



## Pro Seminar Series

The Pro Seminar series is a new flagship offering from Performance Lab. Led by the dynamic team of Ms. Kurlander and Gloria Strickland, member of the board of directors and former ASP Senior Vice President, this eight-week bi-weekly program offers an in-depth exploration of the core concepts and philosophies that power our transformative work. It is specifically designed to develop our senior staff from across the country, ensuring they have a deep understanding of our cutting-edge approach to human development and performance as a catalyst for growth. Participants engage with thought-provoking assigned readings and collaborate in dynamic discussions with our esteemed leaders, including Ms. Kurlander, Ms. Strickland and special guest discussants. Our inaugural sessions featured insights from Antoine Joyce, Senior Vice President and ASP of Dallas City Leader, and Shadae McDaniel, Senior Vice President of Programs and Strategic Initiatives and ASP of New Jersey Director.

The Pro Seminar Series exemplifies our commitment to investing in our people and strengthening our national network. We're confident this program will be a key driver of our continued success and innovation.

## Transformative Community Theatre

The Performance Lab's first production was *The 1619 Project, One-Act Festival* at the Bishop Arts Theatre Center, which was co-sponsored by ASP and Dallas Truth, Racial Healing & Transformation. The festival consisted of seven original plays inspired by *The 1619 Project* and featured a Talk Back led by festival dramaturg and Harvard professor Khalil Gibran Muhammed, Ph.D., with Nikole Hannah-Jones, the Pulitzer Prize-winning journalist who conceived *The 1619 Project*. Ms. Kurlander also directed a play reading of *BALDWIN/KENNEDY*, a new play by Jared Glenn and Jacqueline Salit at the Castillo Theatre in New York City. Additionally, she helmed award-winning playwright Paula Vogel's *Indecent* at the Emerson Theater Collaborative in Sedona, AZ, and directed a workshop production of *This time* by Brian Dang at the Undermain Theatre in Dallas.



# Alumni Leadership Council and Young Professionals

Since its launch in 2018, the **Alumni Leadership Council** (ALC) has spearheaded efforts to engage All Stars alumni across the country. In 2023, many alumni demonstrated how eager they were to give back to All Stars and their communities by developing involvement opportunities at their companies and giving financially. 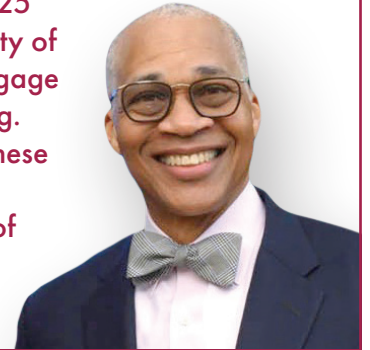
