The All Stars Project is a leading national nonprofit organization that transforms the lives of youth from poor and underserved communities in partnership with caring adults, giving everyone the opportunity to grow. We use the developmental power of performance to bring free afterschool development to our young people of Dallas.



Our Programs

Development School for Youth (DSY)

With a 27-year track record and over 5,000 alumni, the DSY creates leadership training and paid summer internship opportunities for youth in partnership with the business community. This summer, 200 youth participated in in-person, virtual, and hybrid internships provided by partner companies such as AMLI Residential, Bank of Texas, Dallas Regional Chamber, JPMorgan Chase, KPMG, and more. DSY is a model program that prepares youth for the business world and creates meaningful engagement, as our corporate partners respond to new calls of action for diversity and equity in the workplace.

Development Coaching

A fully virtual program of the All Stars Project, Development Coaching matches young people with caring adults and industry leaders. These adults help guide and enhance each young person's professional and personal development. Since 2020, we've matched over 1,000 youth and adults in the program!

All Stars Talent Show Network (ASTSN)

Antoine Joyce-Roach, our Senior Vice President and Dallas City Leader, participated in ASTSN when he was just 12 years old in Brooklyn, and it changed his life. We are proud to continue the legacy of using our innovative performance-based approach to help youth from across the city grow their confidence on and off stage. This past summer, we partnered with Dallas Park & Recreation Department TOPS (Teens Organized & Prepared for Success) to host our annual talent show and over 200 attendees celebrated our young performers!

As a Dallas civic and philanthropic leader, Lynn has dedicated more than 45,000 hours of volunteerism to over 30 different organizations committed to improving education, addressing homelessness, ensuring women’s rights and safety, and growing youth development. Since 2014, Lynn has served as CEO of Young Women’s Preparatory Network, a public-private partnership that creates STEAM-focused schools of choice in an all-girls setting. To date, graduates have a 100% college acceptance rate – many of them first generation college goers. As Workforce Development Czar, she has been a committed leader in supporting youth to find resources and pathways to success, expanding programs that help adults “upskill,” and working with institutions including Dallas College and Workforce Dallas. Lynn is an extraordinary bridge-builder who is Co-Chair of For Oak Cliff, Chair of The Bridge Homeless Recovery Center, part of the AT&T Performing Arts Center Executive Board, Dallas Education Foundation Trustee, The Family Place Foundation Trustee, and Dallas College Foundation Executive Board, to name just a few of her leadership roles in the community.

Byron Sanders is a relentless advocate for education, economic development, and equitable communities. As the President of Big Thought, his primary mission is to narrow the opportunity gap, ensuring young people have the chance to fulfill their innate potential.
